- 5.1 General Manager Report

The GM noted an update to the Rails to Trails item; ONTC has confirmed that they are not interested in the MRCA proposal to convert unused rail beds for recreation trail access. It was also noted that a significant amount of staff time is currently being dedicated to the preparation of documentation required through the CAA Amendments.

#### 6.0 Items for Discussion

### 6.1 Conservation Areas / Trail Upkeep

Regular field work continues including ongoing trail checks after heavy rains. Staff are updating the capital plan to identify upcoming costs for repairs to all attributes on MRCA properties. Additionally, costs are being identified for ongoing maintenance costs specifically for conservation areas, MRCA owned trails, and non-owned trails, to provide clarity in future budget discussions.

## 6.2 Land Management Policy

Updates were presented to the Board, including updating the Ministry from Environment, Conservation and Parks, back to Natural Resources and Forestry, and updating the Fair Market Value Table 4.3(c).

## 6.3 Strategic Plan

Staff have participated in several meetings and met with a consultant to prepare the MRCA Strategic Plan 2024-2028. An overview of the draft, including a summary of the planned goals, was presented to the Board. No concerns were raised. A final document will be presented at a
